**WESTPEX, April 28, 2013**

*President, Akthem al-Manaseer, presided over the April 28, 2013 meeting at WESTPEX which was called to order at 12:05 PM.*

**Minutes:**

*The minutes of the December 2012 PENPEX meeting were accepted as corrected with typographical and spacing corrections. David McNamee moved and Larry seconded the motion. Motion carried.*

**Treasurer's Report:**

*David McNamee reported that there is \$4047.99 banked. Three clubs have not paid their dues and have been sent a reminder postcard (Alameda, Fresno and Mendocino Coast). David will attempt contacting them one more time before these Clubs are put on suspension.*

**New Business:**

- 1) Copies of the proposed By-Laws changes were distributed to those present and have been posted on the Council web-site. Vesma Grinfelds moved that the By-Laws be accepted as revised. Randy Tuuri seconded the motion. The motion carried unanimously (12-0).*
- 2) Akthem will speak with Gary Jensen to see if he wishes to carry on as Youth Coordinator. If needed, he will appoint a new Chairman.*
- 3) A Nominating Committee also need be formed. David, Vesma and Tim were appointed to the Committee.*
- 4) Kristin Patterson, Chairman of PENPEX, present PENPEX 2012 Reserve Grand winner with his "revised" award.*
- 5) The "Apprentice Judge Evaluation Form" was discussed. The purpose of this form is for the Council to be assured that an apprentice juror is sufficiently prepared. An apprentice judge is required to judge at 3 Council Shows with the Chief Judge filling out the evaluation form and returning it to the Jury Coordinator. Clear requirements need be created as to what is required of an apprentice judge. Also, the process for review need be established and explained. David made a motion and Larry seconded the motion to accept the "Apprentice Judge Evaluation" form as created. The motion was carried unanimously.*
- 6) Tim Burgess noted that judges have been assigned for all Shows for the year. Next year, SOPEX will need 2 Council judges as it is unlikely that one will be available from the Northwest Federation.*
- 7) The next Council meeting shall be held at the East Bay Collectors Club Show in Walnut Creek. The slate of officers for the next 2 year term need be established by this meeting.*
- 8) Vesma Grinfelds brought up the idea of having a "Stamp Day" where an assortment of speakers, presentations and auctions might take place. Perhaps June would be a good time for this activity?*
- 9) Gayle Hamilton announced that the San Leandro Stamp Club will be celebrating their 75<sup>th</sup> Anniversary in June!*
- 10) Paul von Gottfried noted that the Santa Rosa Stamp Club is in its 2<sup>nd</sup> year and gaining members!*

## **CNCPS MEETING MINUTES** **EBCC, October 27, 2013**

*Attending: Akthem Al-Manaseer David McNamee Larry Crain Vesma Grinfelds  
Gayle Hamilton Assad Sobkey*

*President, Akthem al-Manaseer, presided over the October 27, 2013 meeting at EBCC which was called to order at 1:00 PM.*

### *Minutes:*

*The minutes of the April 2013 WESTPEX meeting were accepted as corrected with typographical name corrections. The motion to accept the minutes as corrected was approved unanimously.*

### *Treasurer's Report:*

*David McNamee presented the CNCPS Financial Statements. To date, the Mendocino and Napa Clubs have not paid their dues. With the 2014 dues statement, they will be reminded that their Club is in arrears. The CNCPS policy is that Clubs are no longer members if their dues are unpaid for 2 years. He also suggested that the East Bay Collectors Club be compensated for the \$100 rental fee they paid for the meeting room at this venue. That motion passed unanimously and David will issue the check to the EBCC.*

*The Treasurer's Report was approved unanimously as presented.*

### *New Business:*

*1) The Apprentice Judge Evaluation Form has been developed by David McNamee and Tim Burgess. The purpose of the form is to insure that apprentice judges are aware of their duties and responsibilities. The Form provides, in written form, assurance that the expectation of an apprentice judge has been met. The Chief Judge completes the form with every assignment and submits the form to the Jury Coordinator.*

*It was agreed that the Jury Coordinator, Council President and a third party (a qualified judge) will review the accumulated 3 forms for an apprentice (as provided by each Chief Juror) for accreditation of the new Juror. Acceptance of the new Juror shall be a collective decision. Any complaints about any Council Juror shall be brought to this same group. This shall be known as the Accreditation Committee. It was moved by Vesma Grinfelds and seconded that the Apprentice Judge Evaluation Form along with its expectations and procedures be adopted and put to use. The motion carried unanimously. Bob Grosch was welcomed as our newest Council judge having met all expectations of an apprentice judge.*

*Len Lukens, an accredited juror with the North West Federation would like to become a CNCPS judge. He will be contacted and asked to do a "trial" judging assignment, along with the 2 accredited Council Judges.*

*2) The Nominating Committee reported that both the current President (Akthem Al-Manaseer) and Vice President (Larry Crain) wish to retain their positions. Nigel Moriarty has agreed to have his name on the slate for Treasurer. Gayle Hamilton may wish to assume the position of Secretary. Jim Busse has also expressed some interest in a position.*

*3) David McNamee volunteered to produce and publish the "Courier" starting in 2014! Ron Biell is overtaxed with job related responsibilities.*

*4) The Chaloner Award Committee was appointed. It will consist of: David McNamee, Bill Barlow and Roy Teixeira (last year's recipient).*

*5) David McNamee was "congratulated" for being the new CANEJ Chairman – he is now in charge of all APS judges in the USA.*

6) *News from SOPEX: Larry Crain announced that another North West Confederation judge may be available for the event. If so, only 1 Council judge would need to make the trip to Medford.*

7) *Akthem noted that the list of Council judges need be reviewed. It was suggested that Tim Burgess, Jury Coordinator ask the current list of judges if they plan on accepting an assignment in the next 2 years. Some judges on the list have not judged any event in the past 5 years.*

8) *Jim Dempsey has agreed to Chair and Underwrite COALPEX to be held either the 2<sup>nd</sup> or 3<sup>rd</sup> week-end of June 2014. This would be the return of COAPEX after a 3 year hiatus; David McNamee is willing to be in charge of the exhibits, awards, publicity and other tasks along with other volunteers. The dealers are eager to have an event at that time of year at the same Walnut Creek venue since there are no Bay Area stamp events for 5 months before and after that time.*

*David will contact the city of Walnut Creek to check for dates. Nine dealers have already agreed verbally to Jim Dempsey who feels he can get more dealers to participate. A final answer should be pending in a few weeks. Details shall be forthcoming at the next Council meeting to be held at PENPEX in December.*

9) *Larry Crain asked if there was an update to the Council hosting a "Philatelic Day" as was discussed at the previous WESTPEX meeting. There was no update.*

## **Paul Glass Awarded APS 50-Year Medallion**

Paul Glass grew up in St. Paul, Minnesota. He graduated from the University of Minnesota in 1960 with a degree in Political Science. Following graduation, he served in the U.S. Air Force for 26 years, retiring in 1986 as a Lt. Colonel. While in the military, Mr. Glass earned a degree in Languages from Yale University, a degree in History from the University of Maryland, and a Masters Degree in Business from the Air Force Institute of Technology.

Following his military service, Mr. Glass worked for the County of San Bernardino, California, retiring in 2002 as the Chief of Engineering and Operations for the County's Waste System Division.

Mr. Glass has been a collector since the fourth grade and has interests in the U.S., Canada, and the U.N. Currently, he is concentrating on the classic worldwide stamp issues (1840-1940). He is a life member of the American Philatelic Society (APS), and a member of the Board of Directors of the International Society of Worldwide Stamp Collectors.

He is an active member of the Nevada Stamp Study Society in Sparks, Nevada. He serves on the Board of Directors and Committee for the annual Greater Reno Stamp & C over Show. From 2007 to 2011, he held the office of Treasurer. Mr. Glass is certified as a Boy Scout Merit Badge counselor and is the liaison to the APS for the local chapter. And just to keep a little busy Mr. Glass is listed in the APS estate advisory directory. He presented a local stamp club program last fall outlining the qualifications and duties to help family and heirs with stamp collection decisions.

In July, Paul Glass received his APS 50-year medallion at a meeting of the Nevada Stamp Study Society. The group picture was taken at the July 27 meeting with 29 members being present.

The Nevada Stamp Study Society meets on the 2nd and 4th Saturday from 10 a.m. to about noon. An auction is held at the first meeting of the month with up to 60 items on display. The second meeting of the month is consignment sales and an educational program. In January, a new website was established which received a Silver award in the 2013 APS web site competition for combined club/society and stamp show.

## **An Engineering Victory of the First Order: Hoover Dam**

After winning the Holmsten Award at the Greater Reno Stamp and Cover show, I was asked to write a story about my Hoover Dam post card exhibit. I'd like to tell you about why I chose that subject, why real photo post cards, and how I put it together.

I am an employee of the Bureau of Reclamation and I actually had the opportunity to work at Hoover Dam for about four years. Every work day I made the 70-second ride down and minute and 10 second ride up the elevators (a fact relayed to the tourists everyday) to and from the top of the dam to the powerhouse.

I walked along the gallery (tunnel) built through the dam to reach the powerhouse. I saw the giant turbines on both sides of the river. I felt the powerhouse shake as turbines were started and stopped. I've been inside the scroll cage of turbine – the lower level where the water comes in to turn the giant turbine and generate electricity. I've walked inside one of the 50-foot diameter diversion tunnels when it was opened up for maintenance. I've been to Stoney Gate at the end of the diversion tunnel. And I've stood on the ramp of the powerhouse and looked back on the dam. It truly is "an engineering victory of the first order" as Franklin Roosevelt described in his dedication speech, but also majestic and grand..

Why real photo post cards? That was an easy one. Although there are plenty of linen post cards from there of construction, I wanted something that reflected the reality of the time. The Bureau of Reclamation documented the monumental construction project with black and white photos many of which were turned into real photo post cards. It just seemed like a simple, yet elegant way to present the dam.

Although I spent four years at the dam, and I pretty much knew the history and politics surrounding why the dam was built, I didn't know the details of construction. Low and behold, the Bureau of Reclamation has megabytes worth of information on its website. I also found a book with a compilation of several in-depth stories on the construction, written at the time of construction. Finally, I got a tourist pamphlet printed shortly after completion of the dam. Armed with facts and information, I set about writing my story.

The exhibit started as a one-frame exhibit and I used every post card I owned! Over the years, I expanded the exhibit to two frames. I thought there weren't enough post cards to be able to expand it to a third frame and essentially left it alone. One day after stamp club, I thought I'd take a look on line just to see if there were any post cards on sale that I didn't have. Wholly cow! There were enough post cards to fill another frame, all on sale right then — If I won the auctions. Well, I didn't win them all, but I did win enough and Friday morning, right before we left to go set up for the stamp show, I put in the last postcard.

So I will keep looking for post cards – I know there are several out there, since I lost the bids on them. In the mean time, maybe it's time for this exhibit to go to a World Series of Philately show....
